The following matters have been raised to draw items to the attention of Haswell Parish Council. These matters came to the attention of Mazars LLP during the review of the Annual Governance and Accountability Report (AGAR) for the year ended 31 March 2018. This report must be presented alongside the AGAR to a full meeting of the smaller authority for review.

The review of the annual return may not disclose all shortcomings of the systems as some matters may not have come to the attention of the auditor. For this reason, the matters raised may not be the only ones that exist.

Except for the matters reported below on the basis of our review of the annual return, in our opinion the information in the annual return is in accordance with proper practices and no other matters have come to our attention giving cause for concern that relevant legislative and regulatory requirements have not been met.

- Fixed assets at Box 9 was initially incorrect because the entry was not adjusted for acquisitions and disposals during the year. In 2018/19 the Council should ensure that the Annual Governance and Accountability Return is prepared in accordance with proper practices.
